RE: NOTICE OF VIOLATION OF K.A.R. 82-3-128 for failure to verify the transfer of the UMBERGER lease, located in Section 7, Township 19S, Range 6E, CHASE County, Kansas.

Dear Operator:

Conservation Division Staff finds that you are in violation of K.A.R. 82-3-128 for your failure to verify requested information regarding the transfer of the UMBERGER lease, located in Section 7, Township 19S, Range 6E, CHASE County, Kansas.

K.A.R. 82-3-128 provides that the Conservation Division may require the verification of any information necessary to administer Commission rules, regulations, or orders. K.A.R. 82-3-128 makes the failure to verify requested information punishable by a \$100 penalty.

On July 12, 2013, Staff mailed you a compliance letter requesting compliance with K.A.R. 82-3-128 by August 9, 2013, regarding the transfer of operator responsibility for the UMBERGER lease. That compliance deadline has passed, and you have failed to provide Staff with a T-1 for the transfer or to otherwise notify Staff that you are not the operator. THIS IS YOUR FINAL WRITTEN NOTICE OF THE VIOLATION. However, as a further courtesy, Staff will provide you with 14 additional days to comply with Staff's request for verification of the transfer before turning the matter over to Commission legal staff with a recommendation for an administrative penalty. As such, you have until November 26, 2013, to file the requested T-1 form, or contact the undersigned if you are not the operator of the above referenced lease. If by 5:00 p.m. on November 26, 2013, you have not remedied the violation, I will refer the violation to Conservation Division legal staff with a recommendation for the appropriate monetary penalty and that your operations be shut in until brought into compliance.

I urge you to provide the requested information to remedy the above violation(s) and avoid further compliance action by the Commission. Please include a copy of this letter with the T-1 form you file with the Conservation Division.
