

KNOW ALL MEN BY THESE PRESENTS, that on the 7th day of July, 2010, in an action then pending in the District Court of Greenwood County, Kansas, in the Thirteenth Judicial District of the State of Kansas (the "Court"), in which EXODUS GAS & OIL LLC was substituted as the plaintiff for the original plaintiffs GASROCK CAPITAL, LLC and MIDTOWN ACQUISITIONS L.P., f/k/a DK ACQUISITION PARTNERS, L.P., and ADMIRAL BAY (USA) INC. and ADMIRAL BAY RESOURCES, INC. were defendants, judgment was rendered in favor of the plaintiff and against the defendants (the "Judgment").

AND WHEREAS, in said Court, it was further considered, ordered and adjudged that in case defendant Admiral Bay (USA) Inc. should fail to pay forthwith to plaintiffs the Judgment, together with the interest thereon, and the cost of said action, an order of sale be issued to the Sheriff of Greenwood County, in the State of Kansas, commanding him to advertise and sell according to law, among other property, the following described property located in the County of Labette, State of Kansas, to-wit:

AND WHEREAS, on the 7th day of July, 2010, the Court having carefully examined the proceedings of the Sheriff in making said sale, and being satisfied that said sale had been made in all respects in conformity to law, and the statutes in such cases made and provided, it was on the motion of the plaintiff considered, ordered and adjudged by the Court that such sale was confirmed and the Clerk of said Court was directed to make an entry in the journal that the Court was satisfied of the legality of said sale, and an order was made by the Court confirming said sale, which sale was not subject to any rights of redemption, and directing said Sheriff to execute to the Purchaser of the Foreclosed Property at said sale, a good and sufficient Sheriff's Deed to the Foreclosed Property;

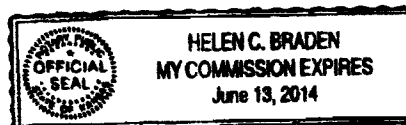
