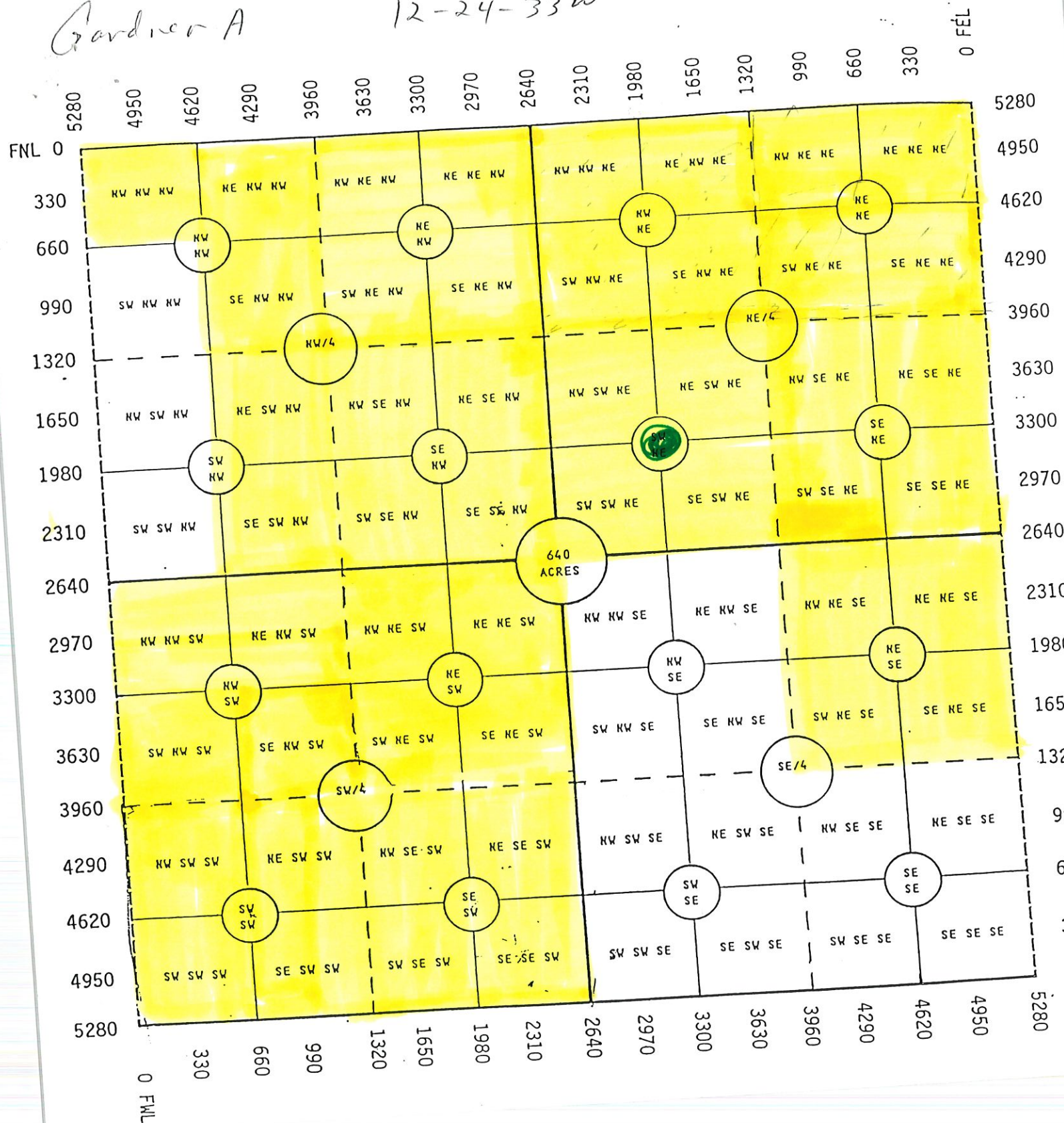

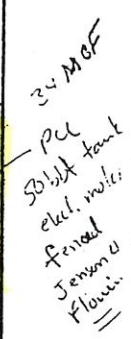

This Assignment, Bill of Sale and Conveyance (hereinafter called "Assignment") is made between Seagull Energy E&P Inc., a Delaware corporation, and SGO Petroleum Inc., an Oklahoma corporation, both having an address of 1001 Fannin, Suite 1600, Houston, Texas 77002 (hereinafter collectively called "Assignor") and Oil Producers, Inc. of Kansas, a Kansas corporation, having an address of 2400 N. Woodlawn, Suite 230, Wichita, Kansas 67220 ("Assignee").

In consideration of the mutual promises made between Assignor and Assignee and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms of a Purchase and Sale Agreement dated February 10, 2000 ("Agreement"), Assignor hereby bargains, sells, assigns, transfers and delivers unto Assignee, with special warranty of title, all of Assignor's right, title and interest in and to (i) all property and property interests described in Exhibit "A" hereto and (ii) all property and property interests listed in paragraphs (a) through (j) immediately below, to the extent such property or property interests are a part of, grant rights in, or are associated with the property and property interests described in Exhibit "A" but only to the extent that they cover and apply to the property and property interests described in Exhibit "A" (collectively herein referred to as the "Property"):

- (a) Leases. Leasehold interests in oil and/or gas, including working interests, carried working interests, rights of assignment and reassignment, and other interests under or in oil, gas or mineral leases, and interests in rights to explore for and produce oil and gas.
- (b) Fee Interests. Fee interests in oil and gas, including rights under mineral deeds, conveyances or assignments.
- (c) Rights in Production. Royalties, overriding royalties, production payments, net profits interests, rights to take royalties in kind, or other interests in production of oil and gas.
- (d) Rights; Working Interests. Rights and interests in or derived from unit agreements, orders or decisions of state and federal regulatory authorities establishing units, joint operating agreements, enhanced recovery and injection agreements, farmout agreements and farmin agreements, options, drilling agreements, exploration agreements, assignments of operating rights, working interests and subleases.
- (e) Easements. To the extent transferable, rights-of-way, surface or ground leases, easements, servitudes and franchises acquired or used in connection with operations for the exploration, production, processing and transportation of oil and gas with respect to the properties and interests described in paragraphs (a) through (d) above.
- (f) Permits. To the extent transferable, permits and licenses of any nature owned, held or operated in connection with operations for the exploration, production, processing and transportation of oil and gas.

(g) Wells. Producing, non-producing, shut-in, temporarily abandoned, and abandoned oil and gas wells, salt water disposal wells, injection wells and water wells located on the property or property interests described in Exhibit "A" hereto and used in connection with the properties or interests described in paragraphs (a) through (f) above.

(h) Facilities. All facilities, building, improvements, gas conditioning and compression facilities, gathering lines, flow lines, injection lines and pipelines and appurtenances located on the real property and on lands included in, or which are related to, the property and property interests described on Exhibit "A".

(i) Equipment. All surface and down-hole equipment, fixtures, machinery, inventory and personal property located on the property and property interests described in Exhibit "A" hereto, and used in connection with the properties or interests described in paragraphs (a) through (h) above.

(j) Contracts. To the extent transferable, all contracts and agreements to which the property described in paragraphs (a) through (i) above is subject.

This Assignment shall be subject to the following terms, conditions or exceptions:

1. This Assignment shall at all times be subject to the terms, conditions, exceptions and reservations contained in the Agreement. Such Agreement shall at all times govern rights and obligations of Assignor and Assignee related to the Property transferred by this Assignment, and all interested parties are hereby given notice of its existence.

2. This Assignment shall be effective as of 7:00 a.m., local time, where the Property is located, on January 1, 2000.

3. The terms, conditions or exceptions contained herein shall constitute covenants running with the land, and shall be binding upon, and for the benefit of, the respective successors and assigns of Assignor and Assignee.


4. Except for the special warranty hereinafter given by Assignor, this Assignment is made without warranty of any kind, express, statutory or implied, and Assignor is transferring the PROPERTY WITHOUT ANY EXPRESS, STATUTORY OR IMPLIED WARRANTY WHATSOEVER AS TO TITLE, DESCRIPTION, PHYSICAL CONDITION OF THE PROPERTY (INCLUDING, WITHOUT LIMITATION, THE ENVIRONMENTAL CONDITION OF THE PROPERTY), QUALITY, VALUE, FITNESS FOR PURPOSE, MERCHANTABILITY, OR OTHERWISE, but this Assignment is made with full substitution and subrogation of Assignee in and to, and Assignor hereby assigns to Assignee, all covenants and warranties by all preceding owners or vendors of the Property other than Assignor or any affiliate of Assignor hereto given or made in respect to the Property or any part thereof. Assignor warrants and agrees to defend title to the Property by, through or under Assignor but not otherwise.



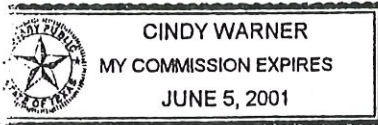

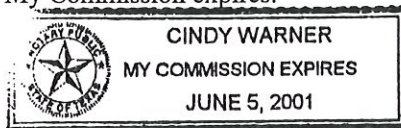
