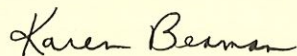
Dear Mr. Hemmen:

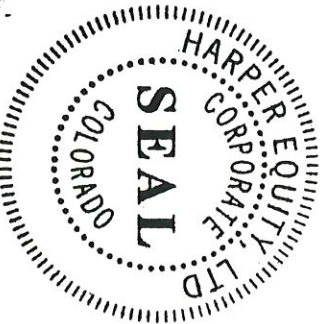
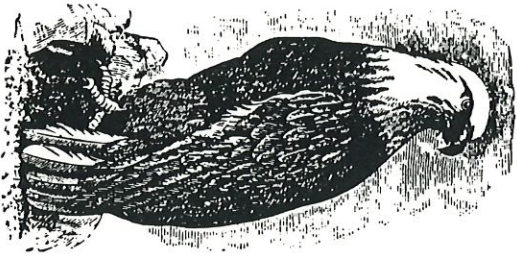
