As a result, I am including assignments from Mull Drilling to the Mull Trust and a number of et al's, from the Mull Trusts and et al's to Schwein Tank and from Schwein Tank to American Warrior, Inc. The result of these assignments is the transfer from Mull to AWI of all the working interest in the above-referenced lease.
