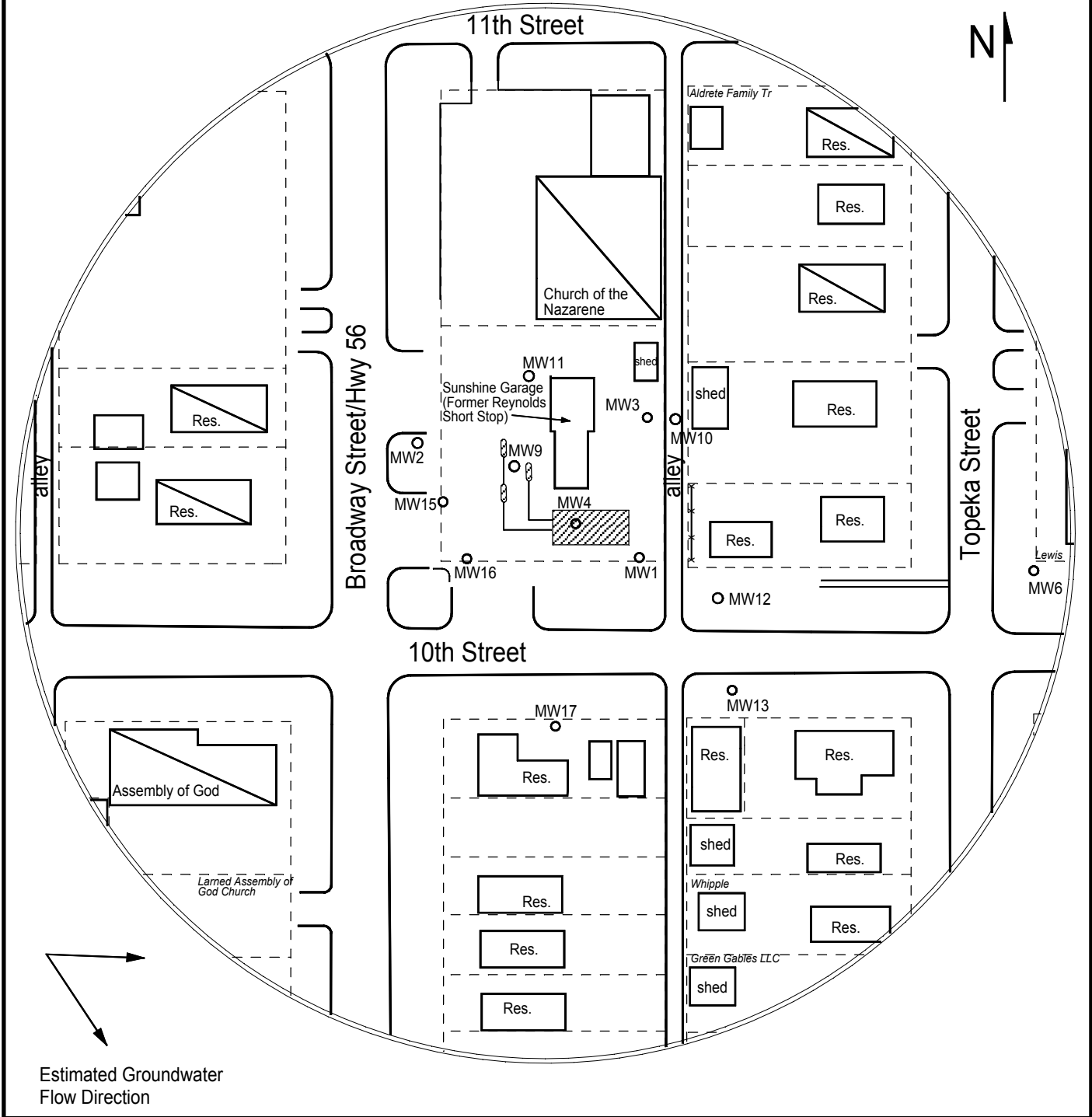


FIGURE 2.1 - 350 FT RADIUS AREA BASE MAP
