The well was fully sealed to the outside environment with a 4 inch casing and a thick metal cap with a galvanized riser. We cut off the cap and tried to measure to depth of the well, but the pumping device was froze about 2 foot down. We therefore packed the 2 foot of casing with cement grout to seal the well.
