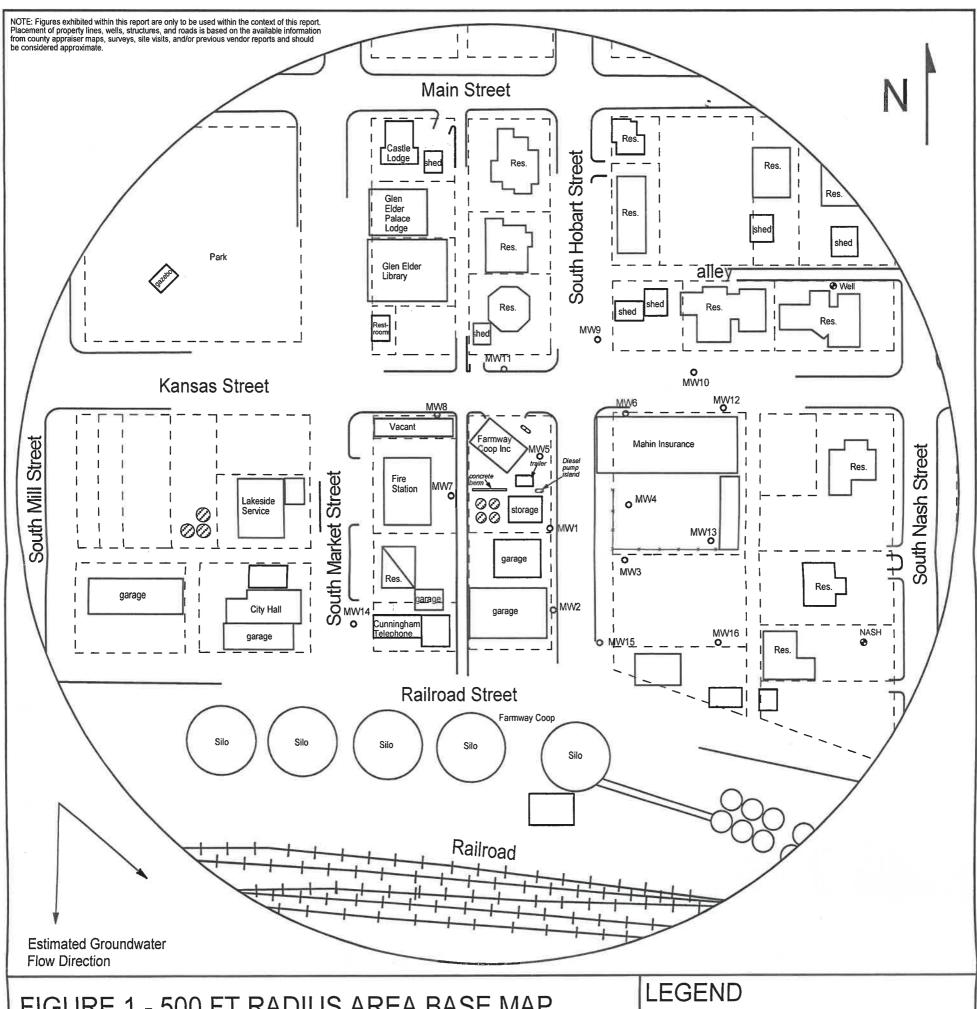


FIGURE 1 - 500 FT RADIUS	AREA BASE MAP	Approximate Location of Former ASTs & Pump Islands
